REGULATIONS OF THE MOTIVATIONAL PROMOTION

"DOUBLE DRIVE CAR PROGRAM"

I. GENERAL PROVISIONS

1.1. The organizer of the motivational promotion, hereinafter referred to as the "Promotion," is MIHI Sp. z o.o., entered into the register of entrepreneurs maintained by the District Court for the Capital City of Warsaw in Warsaw, 14th Commercial Division, under KRS number 0000972725, NIP 5242940809, with its registered office at 03-219 Warsaw, ul. Elektronowa 2E, 2nd floor, hereinafter referred to as the "Organizer."

The Organizer may use the short name of the Promotion: "Double Drive" or "Car Program."

- 1.2. The Promotion is organized in the territory of the Republic of Poland and the countries of the European Union.
- 1.3. The Promotion is conducted from the 14th accounting catalog of 2025 until the 13th accounting catalog of 2026 (i.e., from October 9, 2025 to September 30, 2026).
- 1.4. The Organizer's intention and purpose of the Promotion is not to restrict access to the market for other entities offering products similar in nature to those of the Organizer (hereinafter referred to as "Other Entities").

In particular, the conditions for participation in the Promotion and the terms for receiving prizes are in no way dependent on the number of products ordered from Other Entities or on any actions performed for Other Entities, either during or after the Promotion.

1.5. The Organizer reserves the right to make changes to these Regulations. Any amendments will be announced 14 days in advance on the Promotion's Website and at the Organizer's registered office. The Participant shall not raise any objections or claims in connection with any potential modification of these Regulations.

II. PARTICIPANTS, TERMS OF PARTICIPATION, AND THE REWARD

- 2.1. Participation in the Promotion is open to:
 - Adult natural persons with full legal capacity residing within the Republic of Poland or EU countries,
 - Legal persons or organizational units without legal personality,

registered on the website www.mihi.care and holding a rank not lower than Structural Director.

Unregistered individuals may also participate, provided they complete registration no later than the end of the 6th accounting period of 2026, i.e., by May 6, 2026.

- 2.2. The Organizer undertakes to offer the possibility of obtaining the right to use, for a period of 24 (twenty-four) months, passenger vehicles Volvo XC-60 (Vehicle 1) and Volvo XC-90 (Vehicle 2), upon meeting the conditions specified in clauses 2.3–2.5 below.
- 2.3. To obtain Vehicle 1, the Participant must confirm within their own structure at least 2 (two) new persons at the Director level (first generation) and personally achieve the rank of Structural Director or higher according to the Organizer's marketing plan within the same period in which the mentioned persons are confirmed at the "Director" level.
- 2.4. To obtain Vehicle 2, the Participant must confirm within their structure at least 3 (three) new persons at the Director level (first generation) and personally achieve the rank of Business Director or higher according to the Organizer's marketing plan within the same period in which the mentioned persons are confirmed at the "Director" level.
- 2.5. To effectively receive the vehicle, the qualified Participant, after meeting the above conditions (2.3 or 2.4), must sign the appropriate agreement with the Organizer within 14 (fourteen) days, accepting the terms of vehicle use.

Refusal to sign the agreement releases the Organizer from its commitment, and the Participant shall have no claims against the Organizer.

2.6. The qualified Participant acknowledges that their financial participation in the Promotion is as follows:

Each qualified Participant, meeting the conditions specified in clause 2.1, acknowledges that their minimum participation in the Promotion is 5% of the monthly vehicle lease payment.

The Participant also acknowledges the obligation to pay a refundable deposit of €500, which will be returned upon the termination of the agreement and return of the vehicle.

If the Participant terminates the vehicle-use agreement before its expiration date, they must pay a contractual penalty equal to three (3) full monthly payments for vehicle use. Details will be defined in the agreement between the Organizer and the Participant.

2.7. The Organizer reserves, and each Participant acknowledges without objection, that the vehicle delivery date depends on its availability from the manufacturer and may change.

If the Organizer cannot deliver Vehicle 1 and/or Vehicle 2, it will, where possible, provide a replacement vehicle of its choice, which the Participant agrees to.

The vehicle shall be delivered no later than 12 (twelve) months from the date of signing the preliminary agreement between the qualified Participant and the Organizer.

Additionally, if due to logistical, administrative, or legal reasons, vehicle delivery becomes impossible, the Organizer may allow the Participant to independently rent the vehicle model (Vehicle 1 or 2) and reimburse the rental costs.

2.8. Participants acknowledge that all vehicles will be registered in Poland and will bear Polish license plates. The Organizer bears no responsibility for any administrative, tax, or other penalties related to the vehicle's use in Poland or abroad.

All risks associated with vehicle use rest solely with the Participant. The Organizer may, at its discretion, replace the vehicle with another prize or equivalent (e.g., monetary or tangible).

2.9. The Participant, under penalty of losing the right to sign the vehicle-use agreement, may not participate in other car programs or similar promotions organized by other companies operating in the MLM (multi-level marketing) sector.

III. COMPLAINTS REGARDING REWARDS

- 3.1. Complaints regarding the Promotion may be submitted via email to konkurs@mihi.care with the note "Promotion Double Drive complaint" no later than October 30, 2026.
- 3.2. The right to file a complaint is granted exclusively to Participants.
- 3.3. A written complaint should include:

the Participant's full name, correspondence address, contact phone number, and a detailed description and reason for the complaint.

3.4. The Organizer will consider complaints based on these Regulations.

3.5. The Participant will be informed of the Organizer's decision by registered mail or email sent to the address provided in the complaint, within 14 days from the date the complaint is reviewed.

IV. FINAL PROVISIONS

4.1. Any disputes arising from the performance of obligations related to the Promotion shall be resolved by a court with jurisdiction according to general rules.

Participation in the Promotion is voluntary, and taking part constitutes acceptance of these Regulations.

4.2. The Promotion is governed solely by these Regulations and applicable laws.

All promotional and advertising materials, including these Regulations, are for informational purposes only.

The appearance of vehicles shown in promotional materials may differ from their actual appearance.

Only the signed vehicle-use agreement between the Organizer and the Participant forms the basis for any claims by the Participant.

- 4.3. The Participant acknowledges that without signing the relevant vehicle-use agreement, their participation in the Promotion is entirely voluntary and cannot give rise to any claims against the Organizer.
- 4.4. These Regulations are available throughout the Promotion on the Promotion's Website and at the Organizer's registered office.
- 4.5. Each Participant who maintains the status of 2 or 3 Director Groups is entitled to extend their participation in the Promotion for another 2 (two) years and obtain eligibility for a new vehicle.
- 4.6. Participants' personal data will be processed in accordance with the Personal Data Protection Act (consolidated text: Journal of Laws 2002, No. 101, item 926, as amended).

The Data Controller is MIHI Sp. z o.o., 03-219 Warsaw, ul. Elektronowa 2E, 2nd floor.

Data will be processed solely for purposes necessary to conduct the Promotion, including complaint handling and prize distribution.

Providing personal data is voluntary but necessary for participation. Participants have the right to access and correct their data.

Data may be processed by entities acting on behalf of the Organizer under Article 31 of the Act.
